TAX RELIEF FOR DONATIONS TO ELIGIBLE CHARITIES

If you contribute €250 in a year (minimum) (Envelopes/Collections) the parish, under the Government Tax Refund Scheme for eligible charities, may be able to claim back some of the tax which you have paid.

A rate of 31% is applied to the all donations over €250.
So in addition to your donation of €250 the parish would receive €112

FINANCIAL STATEMENT 2024**

A sincere thanks to all who contribute to the financial support of your parish. Your generosity is much appreciated.

Inside is a financial statement showing the income and expenditure of the parish for 2024.

First of all we would like to thank all who have honoured their responsibility of supporting their parish financially. Thanks also for your contributions to the collections for the support of clergy.

The figures speak for themselves. Even with a decrease in overall income we managed to have an operating profit of €40,000 on 2023.

The Tax Refund scheme benefited us to the tune of €13,151 up on 2023. This scheme benefits us greatly. (All we have to do is paper work) If you have contributed a minimum of €250 in one calendar year all you have to do is complete the Enduring Certificate form and we do the rest. Under the scheme a donation of €250 will result in the parish receiving €112, from Revenue, effectively making your contribution €362. Forms are available in the Parish Office

At a time when many are coping with financial challenges we appeal to your continued support and once again sincerely thank you for supporting your parish. With the number of contributors reduced we rely very much on the generosity of a smaller number of you.
